**Subject: Trusted Telecom Portal (TTP): Policy regarding input of data pertaining to Non-India Registered (NIR) OEMs**

1. As per the existing procedure, when Telecom Service Providers (TSPs) plan to procure directly from a Non-India Registered (NIR) OEM, the detailed information with regard to the OEM (company) and the product is to be provided in the Trusted Telecom Portal (TTP) by the TSPs. However, if the TSPs procure through India Registered OEMs, these inputs are provided in the portal by the India Registered OEMs.
2. Based on the feedback on interactions with multiple stakeholders and inputs received through COAI, the procedure regarding input of data in the TTP when a TSP plans to procure directly from a NIR OEM has been revised. The revised policy is deliberated in below Paragraphs.
3. In cases where a TSP plans to procure through a NIR OEM, and the NIR OEM has an India Registered entity, then the NIR OEM (parent entity) can nominate its India Registered Entity to interact with the Trusted Telecom Portal through its authorized Nodal Officer. The Letter of Nomination should be ink signed by the authorized signatory of the NIR OEM and supported by an appropriate Board Resolution of the NIR OEM empowering the Authorized Signatory. The format for Letter of Nomination of India Registered Entity by NIR OEM is enclosed as Form 3.
4. Upon such nomination, the India Registered Entity of the NIR OEM would be required to provide the Letter of Authorisation for the nominated nodal officer, as per format given in Form 4, along with the documents mentioned in Paragraph 3 above to the address given below:
